

# Regulation

## 1. Registration:

a) Registration implies the reservation of a place.

b) Cancellation of registration, the amount will only be refunded for serious and sufficient justified causes. This refund must be requested to the e-mail address [coordinacion@toptime.es](mailto:coordinacion@toptime.es) **and at least one week before the race.**

Deadlines for reimbursement:

- Before May 20, 50% of the registration fee will be paid.
- From June 8, the registration fee will be forfeited.

c) The registration fee includes:

- Chip timing (short and long race category).
- A race program.
- Race bib.
- Liquid refreshments during the race.
- Gifts from sponsors, as the case may be.
- Tickets for the Gastronomic Festival and refreshment stations.
- R.C. and Accident Insurance.
- Health assistance in case of emergency.
- Classification in the race.
- Trophies according to the categories described (long race category).
- Trophies according to the categories described (Short race category).
- Official race T-shirt.
- Massages, rest area, stretching and healthy buffet (Long race category).
- Bus transportation service from Uga, where the finish line and the Gastronomic Festival are located, to the start of the different modalities.
- Exclusive access to the Running Zone (long race category).
- Clothes storage for the long and short race.
- Toilets distributed around the circuit.
- Dressing rooms.

## 2. Participation requirements:

a) In the long category will have to be of legal age on the day of the race.

b) In the short category, the participants must be at least 14 years of age on the day of the race under the following conditions:

1. Minors under 16 years of age, will have to present at the time of collecting the bib, the parental or guardian authorization, duly completed, accompanied by a copy of ID of the parent or guardian of the participant. They must also present a document certifying their ability to face the race, which may be issued by an Athletics or Triathlon Club or the corresponding Sports Federation.

2. For those over 16 years, it will be sufficient with the presentation of the authorization of the parent or guardian duly completed.

c) In the Walking category, minors may participate with parental or guardian authorization, which must be presented at the time of collecting the bib, stating that the minor will "always" be accompanied by an adult along the route, indicating, in the authorization itself, the name and ID of the adult who will be responsible for the minor.

d) To know and accept the conditions of this regulation.

e) To know and accept the Responsibility Sheet and the Guide of Good Environmental Practices.

f) The organization declines all responsibility in case of injury, accident or negligence, both first and third parties, as well as the loss of personal belongings of the participants.

### **3. Obligations:**

- a) A sporting attitude and respect for the environment.
- b) Not to leave the route marked by the organization, for each of the categories.
- c) Not to litter or degrade the route (there will be containers at the refreshment points).
- d) Provide assistance to any participant or inform the nearest control.
- e) Follow the instructions of the members of control and organization.
- f) Not to voluntarily obstruct another runner.
- g) Wear the bib visible on the front.
- h) In case of abandonment of the race, it is mandatory to notify any member of the organization and hand over the bib. The emergency and security protocol requires us to count the bibs and verify the arrival of all participants, once the race is over, activating with the absence of a bib.
- i) The Winerun is organized with absolute respect for the environment. It is mandatory to respect the crops, livestock and private property in general.
- j) The bibs are personal and non-transferable.
- k) Do not modify, fold or hide the advertising material.
- l) The organization is obliged to remove from the Winerun circuit, any person who does not wear a visible bib.
- m) Each participant must carry a container (bottle, water bottle, hydration backpack, glass, etc.) with which to be able to refresh themselves at the refreshment posts along the route. The organization will not provide cups or bottles on the course.

### **4. Development of the race and route:**

- a) Bad weather, is not an obstacle for the celebration of the test. As long as the weather conditions are not extreme and do not pose any danger to the physical integrity of the participants. The organization reserves the right to make an alternative route to the initial one or to suspend the race.
- b) There will be two control points and closure of the course for safety measures. The participants of the long race will have to have passed through the refreshment post of Testeyna, departure of the walkers and short race, before 11.00 am. From this point of the route, for all participants of all modalities, there will be another control in Bodegas La Geria at 13.00. Those who do not pass through the established points within the time indicated will be excluded from the race.
- c) Backpacks, the organization is not responsible for the contents of the backpacks of the participants. The collection of the backpacks will take place at the start of the runners. An exclusive transport will be provided for this purpose.

### **5. Documentation:**

The organization will place on the web, the following documentation to download:

- Race profile.
- Route in Google earth, 3 days before the race.
- Authorization sheets.

#### **6. Refreshment points::**

There will be 10 points distributed along the route for runners and 5 for walkers. All refreshment points will contain, in addition to wine from the different wineries, water and ice.

#### **7. Image rights, publicity and data protection..**

The organizing entity reserves the exclusive right to the image of WINERUN, as well as the audiovisual, photographic and journalistic exploitation of the competition.

#### **8. Data protection.**

- a) By registering the participants give their consent to the organization of the event, automatically and for sporting, promotional or commercial purposes only treat their personal data.
- b) In accordance with the Organic Law 15/1995, of December 13, 1995, on the Protection of Personal Data, the participant has the right to access these files in order to rectify or cancel all or part of its contents.
- c) Likewise, the registered participants expressly grant the organization the right to reproduce the name and surname, classification obtained and the participant's own, the category, the sports mark made and its image.
